However, the benefit of that growth also comes with major risks to the economy. Since shadow banks are not depository institutions, they do not have deposits to lend out to borrowers. Instead, they rely on money from investors for making loans. Unlike deposits that are FDIC insured, investor dollars collected through the shadow banking industry are not insured.
